I'm honoured to have you as part of the vision and I look forward to building wealth with you.





How are cycles fulfilled?



01. Investor Capital Deployed Tajmas receives investor funds and prepares for deal fulfilment.



02. Stock Secured at SourceCapital is used to purchase discounted bulk stock from trusted Saudi suppliers.



03. Shipment to Dubai InitiatedSupplier ships stock to Tajmas' logistics partner in DAFZA with documents pre-alerted.



04. Stock Received & RegisteredGoods arrive and are held securely under
Tajmas's name, with full traceability and control.



05. Initial Quality InspectionTajmas inspects quantity, packaging and seal status to meet buyer standards.





06. Secure Buyer Commitments

Pre-confirmed buyers and deal terms are locked in to accelerate order execution.



07. Buyer Inspection

Buyer inspects goods at the warehouse and confirms acceptance.



08. Payment from BuyerBuyer pays Tajmas directly via bank transfer.



09. Stock Released

Upon payment confirmation, Tajmas instructs logistics to release stock to the buyer.



10. Profit Distribution

Net profit is calculated and investor receives their monthly return.


