# Terms and Conditions

## Article (1)

- 1.1 Contract Term: The term of this contract is 12 months, and shall be automatically renewed from the date of signing by both parties, unless both, or one of the parties breach the articles agreed upon.
- 1.2 Conditions of Transportation: Second Party shall agree to comply with the standards and conditions of transportation for the packages, as required by the conditions of carriage behind the bill agent in any way which may lead to a violation of the laws of any state. Anker shipping does not accept any transportation of money or bonds. First party excludes all liability for shipments of such items accepted by mistake, or in the following conditions; incorrect shipment information, incorrect address, shipment loss, damage or delay caused by events the first party cannot control, including but not limited to natural disasters, weather conditions, or acts of omissions of public authorities (including customs and health officials).
- 1.3 Confidentiality: All data of this agreement related to the convention, prices, and services provided by Anker shipping to the client, shall remain confidential between both parties. Therefore both parties may not disclose any information specific of this agreement to any third party.

# 1.4 Responsibilities

1.4.1 The Freight Agent has offered to provide warehousing facilities and logistics support as collection, safe keeping, delivery, air shipping, charter, hold and release service, inspection of goods, customs clearance and any other logistic service required from second party.

- 2.1.1 The Freight Agent is liable for the clearance of the shipment. In the event that the goods are found to be wrongly declared it will be the responsibility of the client.
- 2.1.2 Hold and Release services offered by Anker shipping as Anker shipping receiving the shipment in their warehouse accompanied by instruction from supplier and collecting the payment which mentioned by supplier from the buyer via bank transfer, exchange transfer or cash, Then Anker shipping release the shipment to the buyer and release the payment to the supplier.
- 2.1.3 The Freight Agent shall hold the shipment in trust for and on behalf of second party and shall not release it without written consent from second party.
- 2.1.4 The second party shall be authorized one person to give instruction for release / delivery of shipments to the customers by freight agent in case of import shipment from suppliers out of Dubai.

In case of export Anker shipping will not release the shipment unless getting the written instructions from seller/shipper in Dubai.

- 2.1.5 The Freight Agent shall insure all shipments inside warehouse cover under fire policy. In case of any shortage, loss damage, theft of shipment which was not reimbursed, fully or partly, by the insurance for any reason, then freight agent shall be liable to compensate second party.
- 2.1.6 Time is of the essence of this agreement and freight agent shall be responsible to meet the delivery time specified in the delivery instruction provided by second party. In case of receipt of delivery instruction from second party for delivery of any shipment, freight agent shall ensure to get company stamp, proper signature with the name of the person and time of delivery. Freight agent shall be responsible for wrong deliveries. Freight agent shall furnish reports relating to inventory, collection, and deliveries etc.

Our responsibility is to receive the goods, ship them and store them in our company's warehouse under this contract

- 3 Article (2)
  - 2.1 Payment Terms: All invoices to be settled within 10 days after the invoice is made or if the credit limit that is Aed 20,000 is reached. Failure in making the overdue payment may result in the suspension of all services rendered.
- 4 Article (3)
  - 3.1 Agreement Termination: This agreement is null and void in case of any party having breached the terms of this contract agreed upon. This agreement is null and void in the event of bankruptcy of one of the parties. This contract is mutually binding to the parties in all of its terms and any dispute arising between the parties must be resolved by the courts of Dubai Airport Free Zone or the highest competent authority in UAE. The second party agrees on the prices, and terms of dealing provided for in this agreement. This agreement must be made and entered in two copies, and each party must have a copy of this agreement.
  - 3.2 Other Agreement Points: The freight agent will supply the second party with any lists of prices for other shipping services not covered in this contract upon his request. Furthermore the first party holds no responsibility in case the second party decides to take advantage of these services or not. In regards to all shipments provided for in this contract, the customer shall provide all necessary customs documents requested by UAE authorities in order to ensure the clearance of Customs processes in case of detention of shipments by Customs at Dubai Airport Free Zone. The Freight agent is not responsible for the detention of any shipment that does not match the conditions of shipments applied by government departments inside or outside UAE
